# EXPERIENTIAL COURSE DEVELOPMENT AND STUDENT MENTORING

Course Development: Financial Decision-Making and Central Banking, National University "Kyiv-Mohyla" Academy, May/June 2021

- Course will expose students to the key concepts and importance of financial literacy to enable them to play a more informed role in the further development of the Ukrainian economy
- Course will enhance the students understanding of the U.S. Federal Reserve System and ECB, as well as the role of the National Bank of Ukraine in developing, implementing and communicating monetary policy
- Networking component: students will have an opportunity to meet experts in financial literacy, central banking and finance; course is designed to impart a greater interest in economics and finance as a subject for advanced study and as a basis for a career

Course Development: Immersion Experience in Applied Economics and Policy – The Transformation of Poland to a Market Economy (Economics 70)

- Interdisciplinary course exposing students to the path of development taken by Poland following the collapse of the Soviet Union and its economic sphere of influence; combines history, culture, economics, politics and language
- Study abroad component: students develop research projects, travel to Poland to complete projects in collaboration with Polish students, faculty and professionals
- Responsibilities included: developing, teaching and updating the course, collaborating with Polish counterparts, reviewing/accepting student applications,

determining a budget, arranging much of the in-country itinerary and activities, providing students with off-campus orientation and logistical assistance in country

Course Development: Fed Challenge (Economics 78)

- Co-teach with colleague, designed to teach students how to analyze macroeconomic data, read policy research, understand current monetary policy and improve financial literacy; prepares students for the College Fed Challenge competition held annually at the Federal Reserve Bank of Boston
- Responsibilities include developing and teaching this dynamic, real-time course, determining an annual budget, arranging travel and lodging for competition days
- Outcomes: Winner of the National Fed Challenge Competition (remote) conducted by the Federal Reserve Board of Governors and Boston District winner, 2020; Second place at Nationals and Boston District winner in 2016; Second place finishes in 5 of the prior 9 years in the Boston District, which regularly includes Harvard, Yale, MIT and Brown.
