DATA COLLECTION

I have recently finished collecting a three wave Longitudinal Sentiment Dictionary from members of an online Weight Loss Community, Bright Line Eating, LLC. In conjunction with the Neukom Institute and Dartmouth Computer Services, I will begin developing computational tools to assist in the collection of qualitative data from this same population, including network measures, open-ended surveys, and in-depth interviews.

In the last 9 months, I have completed 47 in-depth interviews with members of the Bright Line Eating online weight loss community. Each interview is approximately 120 minutes long.
